I am to invite your kind attention to letter No. R&S/09/Misc./19141-19240 dated 20.7.09 addressed to you by the Registrar, M.D. University, Rohtak containing instructions to be followed while making admissions/sending the registration returns etc. alongwith various fee including Youth Welfare Fee, Holiday Home Fee and Entry Fee for the Zonal Youth Festivals and Techno-Management Fest etc.

The orders passed by the Vice-Chancellor with regard to enhancement of various fee w.e.f. the current session 2010-11 were conveyed to you vide this office letter No.DSW/2010/4302-4952 dated 20.5.2010.

The above orders/action taken by the Vice-Chancellor has been considered and approved by the Executive Council under Reso.No. 4 dated 10.7.2010. The Resolution reads as under :-

4. Enhancement of rates of Youth Welfare Fee and Holiday Home Fee

Considered the action taken by the Vice-Chancellor on May, 18, 2010 in the anticipation of the approval of the Executive Council in enhancing the rates of the following fees w.e.f. the session 2010-11 as under :-

1. Youth Welfare Fee i) For non-Professional Courses	Rs.30/- per student per annum (Rs.10/- to be retained by College / Instt. Concerned and Rs.20/-per student per annum be remitted to the Director Youth Welfare, MDU, Rohtak	Rs.60/- per student per annum (Rs.20/- to be retained by College / Instt. concerned and Rs.40/- per student per annum to be remitted to the Director Youth Welfare, MDU, Rohtak
ii) For Professional Courses including D.Ed., BBA, BCA, C.P.Ed., B.P.Ed., M.Ed., M.P.Ed. courses	-do-	Rs.150/- per student per annum (Rs.50/- to be retained by college/Instt.Concerned and Rs.100/-per student per annum to be remitted to the Director Youth Welfare, MDU, Rohtak
2 Holiday Home Fee (All Colleges / Institutions including professional Colleges)	Rs.10/- per student per annum (Full Fee to be remitted to the Director Youth Welfare, MDU, Rohtak	Rs.20/- per student per annum (Full Fee to be remitted to the Director Youth Welfare, MDU, Rohtak)

RESOLVED FURTHER THAT THE REVISION OF FEE AS ABOVE BE MADE APPLICABLE TO THE COURSES IN THE UNIVERSITY TEACHING DEPARTMENTS, P.G. REGIONAL CENTRE, MEERPUR (REWARI) AND ILMS, GURGAON AS WELL.



You are, therefore, requested to comply with the above decision of the E.C. and arrange to remit the required fee on the above revised rates w.e.f. the current session with Registration Return / Continuation Return of the students. All the fees related to this office are required to be remitted through separate drafts in favour of Director Youth Welfare, M.D. University, Rohtak.


