In continuation to this office letter No.AC-VI/15/13736-14307 dated 06.07.2015, it is to inform you that on the repeated requests of the students, the matter has been reconsidered. The Vice-Chancellor, has, under Section 9-A (5) of the M.D.University Act approved amendment in the following Ordinances as under which shall be applicable in respect of the students who were admitted to the 1st semester of their Courses during the session 2014-15:-

Common Ordinance for 2 Year (PG) Courses:

Clause 12 (ii) The candidate shall be treated as promoted to the 2 nd and 4 th semester automatically but for promotion to 3 rd semester, he/she must clear 50% papers of 1 st semester, subject to fulfiment of conditions as laid down in clause-8 of the Ordinance.	to the next semester/class automatically subject to fulfillment of conditions as laid down in clause-8 of the Ordinance.

Common Ordinance for 3 Year (UG) Courses:

The candidate shall be treated as promoted to the 2 nd and 4 th semester automatically, but for promotion to 3 rd semester, he/she must clear 50% papers of 1 st semester, and for promotion to 5 th semester, he/she must clear 50% papers of 1 st , 2 nd and 3 rd semesters taken together, subject to fulfillment of conditions as laid down in clause -7 of the Ordinance.	the next semester/class automatically subject to fulfillment of conditions as laid down in clause-7 of the Ordinance. However, for promotion to 5 th semester, he/she must have

Common Ordinance for 5 Year Integrated Courses:

Existing

Clause-12

The candidate shall be treated as promoted to the 2nd and 4th semester automatically but for promotion to 3rd semester, he/she must clear 50% papers of 1st semester, and for promotion to 5th semester, he/she must clear 50% papers of 1st, 2nd and 3rd semesters taken together, subject to fulfillment of conditions as laid down in clause -9 of the Ordinance.

However, promotion to 7th semester will be allowed only when he/she has cleared the 1st module (1st to 6th semesters).

Amended

Clause-12

The candidate shall be treated as promoted to the next semester/class automatically subject to fulfillment of conditions as laid down in clause-9 of the Ordinance. However, for promotion to 5th semester, he/she must have cleared all the papers of 1st semester.

Provided further that promotion to 7th semester will be allowed only when he/she has cleared the 1st Module (1st to 6th semesters).

In view of the above, you are requested to kindly make admissions to the various Courses as per the above amendment.
