- 3) Under the eligibility conditions for LL.B (Hons.) 5 Year integrated mentioned at (iii) (c) on page 15 "It may be added that 40% marks of SC candidates of Haryana only. The age of candidates should not be more than 20 years (22 years in case of SC candidates of Haryana only) on July 2011.
- 4) The mode of admission for M.Sc. Medical Biotechnology at Sr.No. d on page 13 may be read as under:-  
**If the proposal of the University already sent to the Department of Bio-technology, Govt. of India is approved then admission to M.Sc. Medical Bio-Technology shall be made through National Entrance Test conducted by Jawahar Lal Nehru University or as advised by the concerned Department of the Centre Government.**

- 6) **Electronics Media** may be added at Sr.No.(viii) on page 30.
- 7) Nomenclature of M.Sc. (Human Genomics) given at viii (b) on page 19 be read as **M.Sc. (Genomics)**
- 8) **The Entrance Test (s) question papers shall be both in Hindi and English, as before. Entrance test fee of Rs.200/- is not payable if a candidate applies for admission to only one such course.**
