The Academic Council while considering the above speaking orders vide resolution no. 23 in its meeting held on 23.08.2013 has resolved as under :

## RESOLUTION

"RESOLVED TO RECOMMEND TO THE EXECUTIVE COUNCIL THAT A PENALTY OF RS. 50,000/- BE IMPOSED ON THE COLLEGE AND THAT TWO SEATS OF THE COURSE (TWICE THE NUMBER OF IRREGULAR ADMISSION) BE REDUCED FOR THE SESSION 2014-15.

RESOLVED FURTHER THAT THE ABOVE DECISION BE CONVEYED TO THE NCTE ALSO.

RESOLVED ALSO THAT A LETTER BE ISSUED TO ALL THE AFFILIATED COLLEGES TO ENSURE THAT NO INELIGIBLE CANDIDATE IS ADMITTED TO ANY COURSE IN FITTURE AND THAT IS ADMITTED TO ANY COURSE

The above recommendation of the Academic Council were subsequently approved by the Executive Council vide resolution no. 23 in its meeting held on 18.09.2013 (copy enclosed).

In terms of the above decision of the Executive Council I have been directed to ask you to deposit a penalty amount of Rs. 50,000/- with Registration Branch of this University and the intake of B.Ed. course of your college for the session 2014-15 shall be 198 seats be reducing two seats as per above decision of the Executive Council.
