Consideration of representation of Self-Financing Colleges in deference to Punjab and Haryana High Court orders dated 21.05.2013 in CWP No.

11028 of 2013...

Sir,

Kindly refer to your representation dated nil received in this University on dated 28.05.2013 and letter dated 01.07.2013 on the above noted subject.

Your representation under reference was placed before the Vice-Chancellor who, constituted a committee to look into the matter and submit report. The meeting of the said committee was held on 18.06.2013 and the following issues as raised in your representation were considered by the said committee:

 Disparity in quantified Performa as the same should be prepared at par with other Universities in the State. Moreover, no quantified Performa has been devised by the University for others professional courses/Institutions.

The Criteria for awarding category to the colleges are not at par with other State

Universities i.e. (KUK/CDLU).

3. Surprise Inspection should not be conducted as other Universities in the State do

not carry out the Surprise Inspection (KUK/CDLU)

4. Implementation of Interim State Policy/Guidelines in pursuance to judgment dated 31/10/2002 in TMA Pai foundation case by Hon'ble Supreme Court and Interim Policy regulation of AICT notified vide notification F.37-3/legal (v) /2003 on education also by withdrawing the selection procedure for teaching as well as Non-teaching staff in the college of Education.

To award the marks of teaching faculty at the time of inspection this has been shown by the management on leave on the day of inspection due to one or the

other reasons.

The committee discussed all the above issues in detail and after deliberation, the committee recommended the following :

 Status quo may be maintained regarding revised quantified Performa. However, the University should implement this procedure for all Courses of the Colleges/Institution affiliated to this University.

Categorization of Colleges may be continued as decided by the University bodies

as the University being autonomous as such, competent to frame rules.

 University should conduct inspection by giving notice to the concerned colleges of least 3 working days from the next academic session i.e. 2014-15. However, the

University reserves the right to conduct surprise Inspection.

4. Educational Colleges are not covered under the judgment dated 31/10/2002 passed in TMA Pai Foundation case by Hon'ble Supreme Court hence selection procedure /approval by the University for teaching and non-teaching may be continued. The committee is further of the view that the approval/selection procedure may also be made mandatory for all the courses/Colleges/Institutions

which does not cover under the Interim guidelines of the State Govt. issued in TMA Pai Foundation case.

5. The Inspection Committee will not give marks to the teaching faculty/Non teaching staff who is absent from duty on the day of Inspection even if his appointment is approved by the University, since, the inspections are going to be informed inspection and will be applicable from the next academic session i.e. 2014-15.

6. The marks of non-teaching staff should be awarded where the selection of non-teaching staff was made by the selection committee of the University before issuance of new guidelines by the University and the staff already appointed fulfills the required academic qualifications and is/are still working in the college. The Management of the College will produce the record of Salary etc of these employees from the date when they joined the College/Institute and approach to the University Authority to approve the proceedings of the selection committee with regard to employees already working in the institutes concerned if other wise found eligible for the post.

The above recommendations of the committee were placed before the Vice-Chancellor who has approved the same.
