Sub:- Regarding submission of amount of Corpus Fund to be deposited by the Self Financing Colleges to liquidate the liability in the case of disaffiliation /withdrawal of Affiliation of a College.

Sir/Madam,

It is stated that pursuant to the decision taken by the Academic Council of this University vide Reso. No. 16 in its meeting held on 11.07.2011 you were requested vide this office letter No. Colleges Br/2011/12165-12573 dated 10.10.2011 to deposit the above refundable Security of Rs. 1.00 lacs with the University at any early date. Further a reminder letter dated 23.01.2012 in this regard was also issued to you to deposit the said amount with the University within 15 days from the issue of this letter in order to generate the Corpus Fund under reference. After expiry of above stipulated period of 15 days another reminder letter No. CB-1/2012/8244-8250 dated 08.06.2012 was again issued to you to deposit the said amount with the University with 15 days from the date of issue of this letter. The above stipulated period of 15 days has already been expired and till date you have not deposited the above said amount with the University.

The matter has been considered by the Vice-Chancellor and in terms of orders passed. I have been directed to again and finally request you to deposit the above said amount of Rs. 1.00 lacs with this office in the shape of DD in favour of Finance Officer, M.D. University, Rohtak or with University cashier within 10 days from the date of issue of this letter in order to generate the Corpus Fund under reference. If your college still fails to deposit the above said amount

within the stipulated period of 10 days disciplinary processing shall be initiated against your college as per Act, Statute, Ordinances and rules of the University and no DMC and Degrees and other documents shall be issued to you till the clearance of the above outstanding dues of the University.
