Dear Sir/Madam,

This refers to my earlier letter of even number dated 25th September, 2014 regarding Swachh Bharat Abbhiyan. As you are aware the Swachh Bharat Abhiyan has seen enthusiastic participation from all the higher educational institutions. The Department of Electronics and Information Technology has desired that all the Universities and Colleges to participate on MyGov Platform for sharing information about the Swachh Bharat activities undertaken by the higher educational institutions.

- 2. The following measures may be undertaken to ensure that the Swachh Bharat Abbhiyan continues in a scientific manner and on a sustained basis:
- (i) Since, most of the institutions are spread over large geographical areas and they have different units like hostels, playgrounds, teaching blocks, administrative blocks etc, it is necessary that collection points for these units may be earmarked and a system created to lift the garbage from these points to the main garbage collection point where the entire garbage of the institution shall be collected. The local civic authorities should be informed about the main garbage point and from where the civic authorities shall lift it for appropriate disposal.
- (ii) A senior level officer may be made in-charge to liaison with the civic authorities and to ensure that this system works smoothly and that the premises are kept neat and clean on a regular basis.
- 3. You are, therefore, requested to kindly implement the above in your esteemed University and affiliated Colleges in an effective manner as soon as possible.
- 4. I shall be grateful if the UGC is informed of the action initiated by your university in this regard on a monthly basis for onward transmission to the Ministry every month on email ugc.action@gmail.com.
