It is stated that the inspection committee which visited your institute to verify the compliance of previous conditions of affiliation for the courses cited in the subject has submitted its report. The report of the inspection committee has been considered by the Vice-Chancellor. On the basis of the recommendations made by the inspection committee, the Vice-Chancellor has been pleased to grant of ex-post facto extension/continuation in provisional affiliation for LLB (3 year)=120 seats and BA LLB(5 years)=120 seats for the session 2014-15 alongwith its extension/continuation in provisional affiliation for/from the session 2015-16 in respect of Vaish College of Law, Rohtak. However, the inspection committee has not recommended the introduction of LLM course for/from the session 2015-16. Therefore, the matter for granting provisional affiliation to the LLM course for/from the session 2015-16 could not be considered. Further, this provisional affiliation to the courses mentioned in the subject cited above is subject to the compliance of the deficiencies pointed out by the committee upto 15.12.2015 and also subject to approval of the Central Body. You are, therefore, requested to complete the deficiencies pointed out in the inspection report and submit the compliance report to the University within stipulated period. A copy of the inspection report is also enclosed for the purpose.
