Deficiencies and infrastructure as per NCTE regulation 2014.

Sir/Madam,

As you know the National Council for Teacher Education has revised regulations regarding recognition, norms and procedure for various Teachers Training Programmes vide notifications bearing No. F.51-1/2014-NCTE(N&S) dated 28.11.2014. As per new norms some new courses have been introduced and duration of B.Ed. and M.Ed. has since been increased from one to two years from the session 2015 onward. As per guidelines the NCTE has also revised the qualifications for appointment of Teaching Faculty which have been adopted by the University and notified vide letter No. CB-HI/2015/F.52/8361-8665 dated 20.02.2015. In addition the Institutions while informing the extension in provisional affiliation to run various courses for the session 2014-15 have also been intimated the deficiencies as pointed out by the Inspection Committee that visited the Institution(s).

The deficiencies as pointed out in the Inspection Report and also the appointment of Teaching Staff as per regulations 2014 are required to be made at the earliest possible but it is pointed out that in the absence of non fulfillment of infrastructure, approved Teaching Staff for the existing courses and also for new courses to be introduced w.e.f. the session 2015-17, the teaching of students to be admitted in the institutions would suffer badly. Therefore, these are required to be complied with before starting the next academic session i.e. 2015-17. It has, therefore, been decided by the University Administration that all the deficiencies pointed out earlier and infrastructure to be created including appointment of Teaching Staff as per new regulations be completed positively by 30.06.2015. After that inspections shall be carried out immediately and if deficiencies including shortcoming in Teaching Staff is pointed out, extension in Provisional affiliation for the session 2015-17 shall not be granted and the name of the Institution shall also not to be recommended to the concerned Admission making authority for admission to a particular course for the session 2015-17.

We hope that the Institutions will comply with the above instructions and take timely action to avoid unnecessary delay in the further process.
