Considered the recommendations of the Academic Council made vide Reso. No. 32 of its meeting held on 12.12.2014 that (1) Al-Falah School of Engineering & Technology, Dhauj, Faridabad and (2) Brown Hills College of Engineering & Technology, Dhauj, Faridabad be disaffiliated, in view of grant of status of a Private University to "Al-Falah University, Faridabad" by the State Govt vide No. KW 20/26-2012 UNP (5) dated 4.6.2014 (Annexure A/64 page 211, already circulated) and the request made by the Authorized Signatory of Al-Falah Charitable Trust, New Delhi (Annexure A/65 page 212, already circulated). The courses of B.Tech./M.Tech. being run by the above colleges shall be discontinued in stages as per sub clause (d), clause-12 of Statute 38 re-produced below:

"The discontinuation in respect of an integrated course of study/subject for which it is affiliated shall be in stages as under:

- In the first year, admission to Part-1 class will be discontinued and admission for Part-II, III will continue.
- In the 2nd year, admission to Part-II class will be discontinued and j!) admission for Part-III, if any, will continue.
- In the 3rd year, there may be no admission."
