Disaffiliation of Manav Rachna College of Engineering, Faridabad

"The discontinuation in respect of an integrated course of study/subject for which it is affiliated shall be in stages as under:

- i) In the first year, admission to Part-1 class will be discontinued and admission for Part-II, III will continue.
- ii) In the 2nd year, admission to Part-II class will be discontinued and admission for Part-III, if any, will continue.
- iii) In the 3rd year, there may be no admission.")
