2. Extension in B.Com (Hons.) 3rd Year and its continuation in 1st and 2nd Year for 20 additional seats (i.e. 40 to 60) w.e.f. the session 2015-16.
3. Extension in B.Sc. (Non Medical) 3rd Year and its continuation in 1st and 2nd Year for 80 additional seats w.e.f. the session 2015-16.
4. Extension in B.Sc. (Non Medical) 3rd Year and its continuation in 1st and 2nd Year with an intake of 80 seats w.e.f. the session 2015-16.
5. Extension in M.Sc. (Chemistry) 2nd Year and its continuation in 1st Year for 20 additional seats i.e. (45 to 65) w.e.f. the session 2015-16.
6. Extension in M.Sc. (Physics) 2nd Year and its continuation in 1st Year for 15 additional seats i.e. (40 to 55) w.e.f. the session 2015-16.
7. Extension in B.Sc. (Non Medical) 2nd Year and its continuation in 1st Year for 160 additional seats i.e. (160 to 320) w.e.f. the session 2015-16.
