Sub: Extension of date for late admissions/ promotion in UG/PG courses for the session 2015-16.

Sir/Madam

I am directed to inform you that the Vice-Chancellor has been pleased to extend the last date for admission/promotion upto 21.09.2015 for UG courses with late fee of Rs.2500/- and for PG courses with late fee of Rs.2000/- (except courses for which admissions have been made by the State Government approved agencies) in the University Teaching Departments and the affiliated Colleges for the session 2015-16 on the following conditions:

- (a) Where there is waiting list of candidates, the seats may be filled up from the waiting list.
- (b) Where there is no waiting list, fresh applications may be entertained and admissions be made on the basis of merit.

Further, the Chief Secretary to Govt. of Haryana vide his Memo No.22/146/2015-IGS-III dated 01.09.2015 has informed that there is no impact of order dated 27.07.2015 of the Hon'ble High Court passed in CWP No. 2441 of 2014- Murari Lal Gupta and others Vs State of Haryana in case of reservation given to Economically Backward Persons in General Category. Hence, Economically Backward Persons in General Category mentioned in this office letter No. AC-1/15/ 18267-18867 dated 29.07.2015 be treated as withdrawn and the seats for Economically Backward Persons in General Category kept in abeyance be filled up from the merit list of Economically Backward Candidates on first come first served basis.

The late fee is to be remitted to the University and such cases need not be sent to the Vice-Chancellor for his approval.
