Sir,

I am directed to inform you that on the basis of the report of the Inspection Committee dated 23.08.2014, and you request dated 14.07.2015, the Vice-Chancellor has been pleased to grant Extension in provisional affiliation in the following courses to Ch. Dhajja Ram Janta Mahavidyalaya, Butana, Gohana, Sonepat w.e.f. the session 2015-16 subject to fulfillment of deficiencies pointed out by the Inspection Committee in its report within 3 months (copy enclosed):-

- 1. Extension in M.A (Hindi) 2nd Year with an intake of 40 seats under SFS w.e.f. the session 2015-16.
- 2. Extension in M.A (History) 2nd Year with an intake of 40 seats under SFS w.e.f. the session 2015-16.
- 3. Extension in B.A 2nd Year for 80 additional seats i.e. (160 to 240) and its continuation in 1st year under SFS w.e.f. the session 2015-16.
- 4. Extension in B.Sc. (Non Medical) 2nd Year for 60 additional seats i.e. (60 to 120) and its continuation in 1st year under SFS w.e.f. the session 2015-16.

Further in terms of the orders passed by the Vice-Chancellor, you are not allowed to make fresh admissions in existing PG courses i.e. M.A. Hindi & M.A. History. However, fresh admissions can be made in existing UG courses only for the session 2015-16. Further affiliation to start of M.A. Eng. and M.A. Geography courses cannot be granted at this stage.

After fulfillment of the deficiencies given in the Inspection report, compliance report may kindly be sent to this office within 3 months positively, so that further action may be taken accordingly.
