- Extension in B.A. 3<sup>rd</sup> Year with an intake of 80 seats w.e.f. the session 2015-16.

- Extension in B.Com 3<sup>rd</sup> Year with an intake of 80 seats w.e.f. the session 2015-16.
  Extension in B.Sc. (Medical) 3<sup>rd</sup> Year with an intake of 60 seats w.e.f. the session 2015-16.
  Extension in B.Sc. (Non Medical) 3<sup>rd</sup> Year for additional 160 seats i.e. (160 to 320) w.e.f. the session 2015-16.
- 5 Extension in M.Sc. Mathematics 2<sup>nd</sup> Year with an intake of 40 seats w.e.f. the session 2015-16.
