I am directed to inform you that in view of the provision under point 10 at page 72 and point 14 at page no.73 of the Information Brochure 2013-14, the matter has been considered by the Vice-Chancellor who has been pleased to pass the following orders:-

- 1. That all the candidates reporting for 3rd counseling shall mark their attendance from 10.30 a.m. to 11-00 a.m. Candidates reporting late shall not be entertained.
- 2. That all the candidates who could not appear for the 1t and 2nd counseling be also allowed to participate in 3rd counseling.
- 3. That the seats reserved for different categories will be first offered to the candidates of the concerned reserved category and if any seat of reserved category remains vacant, the same may be converted into Haryana General Category by the concerned HOD and the same will be filled up strictly on the basis of merit. However, if any candidate of reserved category comes for admission during counseling, he/she will be considered first for admission. Even if seats remain vacant the same may be filled on All India Basis after conversion.
