# 22. Amendment in the Common Ordinances of Undergraduate, Postgraduate and 5-Year Integrated Courses (Semester System)

Considered the recommendations of the Academic Council made vide Reso. No. 6 of its meeting held on 29.04.2014 that the Common Ordinances of Undergraduate, Postgraduate and 5-Year Integrated Courses (Semester System) be amended as under to be applicable with effect from the session 2014-15:

### 1. Common 5 year Integrated course:

Clause-12 A candidate shall be treated as promoted to the next semester/class automatically subject to fulfilment of conditions as laid down in Clause-9	Clause-12  xx xx xx xx
above unless detained from appearing in an examination on any genuine grounds.	However, promotion to 7 <sup>th</sup> semester will be allowed only when he/she has cleared the 1 <sup>st</sup> Module (1 <sup>st</sup> to 6 <sup>th</sup> semesters).

# 2. Common 2 year (PG) courses:

Existing	Proposed
Clause-12 (ii) The candidate shall be treated as	Clause-12 (ii) The candidate shall be treated as promoted to the 2 <sup>rd</sup> and 4 <sup>th</sup> semester automatically but for promotion to 3 <sup>rd</sup> semester, he/she must clear 50% papers of 1 <sup>st</sup> semester, subject to fulfilment of conditions as laid down in Clause-8 above:

## 3. Common 3 year (UG) courses:

Existing	Proposed
Clause-11 (ii) The candidate shall be treated as promoted to the next semester/class	Clause-11 (ii) The candidate shall be treated as promoted to the 2 <sup>nd</sup> , 4 <sup>th</sup> and 6 <sup>th</sup> semester automatically but for promotion to 3 <sup>rd</sup> semester, he/she must clear 50% papers of 1 <sup>st</sup> semester and for promotion to 5 <sup>th</sup> semester, he/she must clear 50% papers of 1 <sup>st</sup> , 2 <sup>nd</sup> and 3 <sup>rd</sup> semesters taker together, subject to fulfilment of conditions as laid down in Clause-7 above.
