As you are aware, the University Grants Commission's five schemes (i) Equal Opportunity Cell (ii) Remedial Coaching for SC/ST/OBC (non-creamy Layer) & Minority Community Students (iii) Coaching Classes for Entry into Services for SC/ST/OBC (noncreamy Layer) & Minority Community Students;(iv) Coaching for NET for SC/ST/OBC (non-creamy Layer) & Minority Community Students and (v) Scheme(format III to V) for Persons with Disabilities which were hitherto part of the Merged Scheme, will be implemented as independent schemes during the XII Plan Period in Universities and Colleges. The detailed guidelines of schemes may be seen on UGC website www. ugc.ac.in. The formats may be seen in notice dated 10-02-2014 on the UGC website www. ugc.ac.in.

The enrolment of SC/ST/OBC (non-creamy layer) and Minority students of the Universities should be given in the prescribed format at s.no.12. It may please be noted that those Universities/Colleges which have already been receiving grant under the above scheme during the XII Plan period may give details of the proposal.

The eligible Universities/Colleges may send their acceptance and proposals for each scheme separately in the prescribed proforma.

It is informed that those Universities/Colleges which have already sent the proposals, need not send it again.
