- continuation in 1<sup>st</sup> and 2<sup>nd</sup> year w.e.f. the session 2014-15.
- 7. Extension in B.Sc. (Computer Science) 3<sup>rd</sup> year with an intake of 80 seats and its continuation in 1st and 2nd year w.e.f. the session 2014-15.
- 8. Continuation of B.Sc. (Non-Medical) 1st year to 3rd year with an intake of 80 seats each for 2014-15.
- 9. Extension in B.Sc. (Medical) 2<sup>nd</sup> year with an intake of 80 seats and its continuation in 1st year w.e.f. the session 2014-15.
- 10. Continuation of B.Com. (Pass Course) 1st year to 3rd year with an intake of 80 seats each for the session 2-14-15.
- 11. Continuation of BCA course with an intake of 60 seats for 2014-15.
