- 5. Extension in B.Sc. Chemistry (Hons.) 2nd Year and its continuation in 1st Year with an intake of 40 seats w.e.f. the session 2015-16.
- 6. Extension in B.Sc. Maths (Hons.) 2nd Year and its continuation in 1st Year with an imake of 40 seats w.e.f. the session 2015-16.
- 7. Additional one unit of 40 seats in M.Sc. Physics 1st year course.
- 8 Additional one unit of 40 seats in M.Sc. Chemistry 1st year course.
- 9. Additional one unit of 40 seats in M.Sc. Mathematics 1st year course.
- 10. Additional one unit of 60 seats in B.Sc. Medical 1st year course.
- 11. Additional one unit of 40 seats in B.Sc. (Hons.) Mathematics 1st year course.

You are asked to complete all the deficiencies pointed out the Inspection Committee(s) in its reports upto 15.12.2015, failing which admissions from the session 2016-17 will not be allowed till all deficiencies are removed. Further admissions be made as per letter No.AC-VI/15/25343-924 dated 10.09.15 issued by the Academic Branch of the University.
