1. Extension in B.Sc. Computer Sc. 2nd Year and its continuation in 1st year for 50 additional seats (i.e. 30 to 80) w.e.f. the session 2015-16.
2. Extension in B.Sc. (Non Medical) 3rd Year and its continuation in 1st and 2nd year for 130 additional seats (i.e. 30 to 160) w.e.f. the session 2015-16.
3. Extension in B.A 3rd Year and its continuation in 1st and 2nd year with an intake of 320 seats w.e.f. the session 2015-16.
4. Extension in M.Sc. Maths 2nd Year and its continuation in 1st year with an intake of 40 seats w.e.f. the session 2015-16.
5. Extension in M.Sc. Chemistry 2nd Year and its continuation in 1st year with an intake of 40 seats w.e.f. the session 2015-16.

You are asked to complete all the deficiencies pointed out the Inspection Committee in its report upto 15.12.2015, failing which admissions from the session 2016-17 will not be allowed till all deficiencies are removed.
