- Extension in B.Sc. Computer Sc. 2nd Year and its continuation in 1st year for 50 additional seats (i.e. 30 to 80) w.e.f. the session 2015-16.
- Extension in B.Sc. (Non Medical) 3rd Year and its continuation in 1st and 2nd year for 130 2. additional seats (i.e. 30 to 160) w.e.f. the session 2015-16.
- Extension in B.A 3rd Year and its continuation in 1st and 2nd year with an intake of 320 seats 3. w.e.f. the session 2015-16.
- Extension in M.Sc. Maths 2nd Year and its continuation in 1st year with an intake of 40 seats 4. w.e.f. the session 2015-16.
- Extension in M.Sc. Chemistry 2nd Year and its continuation in 1st year with an intake of 40 5. seats w.e.f. the session 2015-16.
