

INTRODUCTION

The World Trade Organization came into being in 1995. One of the youngest of the international organizations, the WTO is the successor to the General Agreement on Tariffs and Trade (GATT) established in the wake of the Second World War. So while the WTO is still young, the multilateral trading system that was originally set up under GATT is well over 50 years old. The past 50 years have seen an exceptional growth in world trade. Merchandise exports grew on average by 6% annually. Total trade in 2000 was 22-times the level of 1950. GATT and the WTO have helped to create a strong and prosperous trading system globally to unprecedented growth. The system was developed through a series of trade negotiations, held under GATT. The WTO's rules - the agreements - are the results of negotiations between the members. The contribution of WTO in the Indian economy is vital and has covered a lot of areas in terms of Agriculture, Investment, trade, Intellectual Property rights etc. During last decade, developments in WTO agenda (particularly after 2002) and ministerial conferences have geared up various issues in the relation of trade and commerce.
