Report of the Inspection Committee that visited S D Mewat Institute of Technology and Management, VPO Rawli, Ferozpur Zhirikha, Mewat, Haryana with regard to extension/continuation of existing courses for the session 2012-13.

The Inspection Committee comprising Prof. Mukesh Dhunna, IMSAR, M D University, Rohtak and Prof. Nasib Singh Gill, Department of Computer Science and Applications, M D University Rohtak visited the institute for

- (i) extension/continuation of courses MBA with 120 seats,
- (ii) extension/continuation in II year in MCA with 60 seats,
- (iii) extension/continuation to III year in BBA with 60 seats and
- (iv) extension/continuation to III year in BCA with 60 seats

for the session 2012-13:

Observations

The inspection committee physically inspected the documents and infrastructural facilities viz. building, all related labs, computer labs, library, class-rooms, furniture, etc. for all the above said courses and makes the following observations:

1. The institute has no deficiency lying pending since the last inspection for the session 2011-12.
2. AICTE, New Delhi has already issued the extension/continuation for the existing courses for the session 2012-13 (copy attached).
3. The institute has adequate funds available in bank account maintained with Oriental Bank of Commerce as required by the AICTE.
4. The institute has a total of three acres of continuous land registered in the name of society which is sufficient for running the courses specified. The committee has verified the land documents in this regard (copy of statement showing Khasra no./s is enclosed herewith).
5. The construction work is now almost complete and the institute has sufficient classrooms and tutorial rooms to accommodate the infrastructural requirements of the existing courses. The labs are ready for usage.
6. The institute has already made necessary arrangements for getting

the electricity load sanctioned from Dakshin Haryana Bijli Vitran Nigam Limited (copy attached) and the institute has set up/is setting up all general amenities on the campus such as Canteen, Transportation facility (2 buses), drinking water facility, sports grounds etc. The institute has already acquired one Genset of total 5 kva capacity power backup.

7. The admissions to these courses in the institute have been meager for the session 2011-12 as detailed hereunder: MBA 1st year 15, 2nd year 3, MCA 1st year 2, 2nd year 2, BBA 2nd year 3, 3rd year 2, and BCA 1st year 2 and 2nd year 2.
8. The institute has sufficient teaching and non-teaching staff for the courses it is running, however, the appointments of the teachers is yet to be regularized by properly constituted selection committee and the university.
9. The institute has sufficient number of books in its stock and the computers as required under the norms in its inventory. However, none of the new books were added owing to the poor admissions to the courses.

Recommendations

In view of the above observations, the committee recommends the extension/continuation in the

- (i) extension/continuation of courses MBA with 120 seats,
- (ii) extension/continuation in II year in MCA with 60 seats,
- (iii) extension/continuation to III year in BBA with 60 seats and
- (iv) extension/continuation to III year in BCA with 60 seats

for the session 2012-13, to S D Mewat Institute of Technology and Management, VPO Rawli, Ferozpur Zhirkha, Mewat, Haryana.
