Sir/Madam,

Kindly refer to your office letter No. dated 27.07.2015 on the subject cited above.

It is to inform you that the Vice-Chancellor has approved the following schedule of counseling for admission to B.A.B.Ed/B.Sc.B.Ed.4-Year Integrated programme:-

1st Counseling:	01.08.2015 (proposed by the Principal)
2 nd Counselling	upto 14.08.2015
(if seats remain vacant)	

There will be no admission after 14.08.2015 to maintain the statutory provision of clear 90 teaching day per semester. If the number of teaching days fall short due to some unforeseen reason, it shall be the responsibility of the Principal and the concerned teacher to make good the loss by taking extra classes. It is also to inform you that the Hon'ble High Court of Punjab & Haryana at Chandigarh has stayed the reservation in appointments and admissions in State of Haryana of Special Backward Classes (SBC) category in its order dated 27.7.2015 passed in CWP No.2441 of 2014 – Murari Lal Gupta Versus Haryana State etc. The vacant seats for EBP category shall also not be filled up. The University has decided to comply with the above said orders. A copy of letter No.AC-1/2015/18267-18887 dated 29.07.2015 have already been circulated to all concerned, including you (copy enclosed).

You are requested kindly not to fill up the vacant seats for SBC and EBP categories in view of the above decision and admission against such vacant seats be held in abeyance till further orders. The compliance of these orders may kindly be ensured. Rest of the instructions mentioned in Admission Brochure 2015-16 for admission in affiliated colleges available on University website be followed.


