7. Extension in B.A. English (Hons.) 3rd year course and its extension in 1st & 2nd year with an intake of 40 seats w.e.f. the session 2015-16.
8. Extension in B.A. 3rd year course for additional one unit of 80 seats i.e. (400 to 480) and its extension in 1st & 2nd year w.e.f. the session 2015-16.
