Prof. Sunita Malohtra, Dean Academic Affairs could not attend the meeting.

In the light of the observations of the Vice-Chancellor the committee re-looked its earlier recommendations which are then after modified as under:

- (i) The scenario of 2014-15 admissions was such that hardly a few applicants who were desirous of admission were turned back and we have about 300 such Colleges of Education already affiliated with us which are almost equally distributed in all the districts within our jurisdiction. Moreover, the University did not add enough human resource to handle the affiliation of such a large number of colleges since last 6 years. In such a situation the committee, therefore, recommends that new Colleges may not be allowed.
- (ii) As to the existing institutions applying for additional courses the committee finds that NOC be issued after ascertaining that the college has Principal and atleast 50 % of the faculty approved from the University on the day it applies to the university for grant of NOC as per existing norms.
- (iii) Applications of existing institutions for running M.Ed. as an additional programme shall be considered only for those institutions who have completed minimum period of five academic years affiliated with the university and applied for NAAC accreditation. A copy of proof on account of applying to NAAC/visit of the peer team occurred and awaiting certification be also attached. In case of 3 year B.Ed. and M.Ed. integrated course, a Self Appraisal Report be submitted to the University and atleast B grade certification as per NCTE regulations 2014. The college should have Principal and at least 50% approved faculty on the day of submission of such an application for grant of NOC.
