Sub: Continuation in provisional affiliation for the existing Course i.e. B.Ed. with existing intake up to the session 2012-2013.

Sir/Madam,

Pursuant to decision taken by the Academic Council vide Resolution No. 8 of its meeting held on 29.06.2012, a show cause notice was served upon to your college as to why disciplinary action be not initiated for not complying with University direction and also for failure to make up the deficiencies pointed out in the various inspection report with in stipulated period.

In the mean time the University was in receipt of orders of the Hon'ble Punjab and Haryana High Court dated 18.09.2012 in PIL/CWP No. 20056 of 2009 (O&M) case titled "Prashikshit Adhyapak Sangh V/s State of Haryana and others". In terms of the order of the Hon'ble Court, the matter was considered by the Vice Chancellor who has been pleased to allow the conditional continuation in provisional affiliation for B.Ed. Course with earlier existing intake up to the session 2012-13. Accordingly, I have been directed to convey as under:-

1. Continuation in provisional affiliation for B.Ed. course with existing intake upto the session 2012-13.
2. To appoint the deficient teaching faculty/principal according to the prescribed qualifications/procedure of the University as per new rules circulated vide letter No. CB-III/10/108-401 dated 3.1.2011 (a copy of which can also be downloaded from the University Website (www.mdurohtak.ac.in) and also to seek University approval of appointment of above deficient teaching faculty.
3. To appoint the Librarian, Non-teaching staff as per requirements of Central Body/University/State Govt. according to the prescribed qualification/procedure of the University circulated vide letter no. CB-VIII/NT/12/14839-15260 dated 05.11.2012 (a copy of which can also be downloaded from the University website and also to seek University approval of appointment of non teaching staff.
4. To seek the individual approval of appointment in respect of the faculty members whose selection proceeding have already been approved by the University and if they are still on the role of the college.
5. To complete the deficiencies/shortcomings pointed out by the inspection committee in its report(copy already supplied)
6. To furnish an affidavit from 1st Class Magistrate with regard to separate building and land meant for the purpose of college exclusively in the name of institute with an undertaking along with supporting documents that no other institute/school is running on the said land and building the College.

I have further been directed to inform you that the university is going to constitute various inspection committees for verification of compliance of above conditions, short coming/deficiencies made by the college in near future and also to consider the matter for further grant of continuation for the session 2013-14. After verification of compliance, if your college is still found deficient, disciplinary proceeding including withdrawal of affiliation shall be initiated against your college in terms of Act, Statutes and Ordinance of the University and also in view of above decision of the Hon'ble High Court. Inspection Report/Reports/conditions have already been sent.
