**15. Revised Quantified Inspection Proforma for the B.Ed. and M.Ed. Courses**

**Considered:**

- (i) the order of the Hon'ble Punjab & Haryana High Court dated 18.09.2012 passed in PIL/CWP No. 20056 of 2009 (O&M) case titled "Prashikshit Adhyapak Sangh V/s State of Haryana and others"
- (ii) the action taken by Vice-Chancellor in anticipation of approval of the Academic Council in approving the Revised Quantified Inspection Proforma for the B.Ed. and M.Ed. courses ; and

- (3) THAT IN THE NOTE (1) OF THE QUANTIFIED INSPECTION PROFORMAE, THE FOLLOWING WORDS APPEARING IN THE 3<sup>RD</sup> TO 5<sup>TH</sup> LINES BE TAKEN AS DELETED:

**"(three subject experts i.e. not less than a professor, one may be a associate professor with 5 years experience in addition to the principal and management person i.e. president/secretary)".**
