Sub: Withdrawal of Provisional Affiliation in respect of I.P.J. College of Educaiton, Delhi-Rohtak Road, VPO Ismaila, Distt. Rohtak (Haryana) for B.Ed. regular course w.e.f. the session 2009-10. *Subject to final outcome of court case.*

Sir/Madam,

It is stated that the Northern Regional Committee of the NCTE vide its 209th meeting held from December 26th to 28th, 2012 as decided that the recognition already withdrawn for the B.Ed. and D.Ed. course of your institution i.e. I.P.J. College of Education, VPO Ismaila, Distt. Rohtak (Haryana) shall stand and remain the same. A formal letter dated 25.01.2013 from the NCTE in this regard has also be received (copy enclosed)

In the light of the above decision of the Central Body i.e. NCTE the matter was placed before the Academic Council for consideration and decision. The Academic Council vide resolution no. 32 of its meeting held on 15.04.2013 (copy enclosed) has resolved as under:

RESOLUTION

“RESOLVED TO RECOMMEND TO THE EXECUTIVE COUNCIL THAT IN VIEW OF THE DECISION OF THE NCTE TAKEN IN THE 209TH MEETING OF THE NRC HELD FROM DECEMBER 26TH TO 28TH, 2012 AND ORDERS OF THE NCTE AS CONVEYED TO THE UNIVERSITY VIDE LETTER NO. F.NRC/NCTE/HR-961/209TH MEETING/2012/37229 DATED 28.01.2013 (ANNEXURE P/2 PAGES 82-84), THE PROVISIONAL AFFILIATION OF I.P.J. COLLEGE OF EDUCATION, VPO- ISMAILA, DISTT. ROHTAK FOR B.ED.


COURSE BE WITHDRAWN WITH EFFECT FROM THE SESSION 2009-10, AND THAT THE ADMISSIONS MADE IN THE COLLEGE DURING THE SESSION 2009-10, 2010-11, 2011-12 AND 2012-13 IN VIEW OF THE ORDERS OF HON'BLE HIGH COURT BE SUBJECT TO FINAL DECISION OF THE HON'BLE HIGH COURT."

The above recommendation of Academic Council were subsequently approved by the Executive Council of this University vide the resolution no. 24 of its meeting held on 26.04.2013 (copy enclosed).

In term of the above decision of the Executive Council, I have been directed to convey you that the provisional affiliation of I.P.J. College of Education, VPO Ismaila, Distt. Rohtak has been withdrawn w.e.f. the session 2009-10 and the admission made in the college during the session 2009-10, 2010-11, 2011-12 and 2012-13. In view of the order of the Hon'ble High Court shall be subject to final decision of the Hon'ble High Court.
