Inspection Report of Kedar Nath Aggarwal Institute of Management, Charkhi Dadri with regard to checking of compliance report/infrastructure - extension/continuation in provisional affiliation for existing BBA course for the session 2012-13

The Inspection Committee comprising of Prof. H. J. Ghosh Roy, Dr. A. S. Boora and Dr. Pardeep Ahlawat visited Kedar Nath Aggarwal Institute of Management, Charkhi Dadri on 10.07.2012 with regard to Extension/Continuation in provisional affiliation of BBA course with existing 60 seats for the session 2012-13.

Observations

After physical verification of the available infrastructural facilities of the Institute for the above said programmes, the committee makes the following observations:

1. **Compliance:** The committee verified the compliance of the conditions imposed by the earlier Inspection Committee and the Institute has fulfilled most of the conditions.
2. **Teaching Faculty:** Besides Director, the Institute has one Associate Professor for BBA programme. The institute requires at least three additional faculty members apart from the guest/visiting faculty w. e. f. session 2012-13. However, the Institute gave advertisement on 18th April, 2012 and are in process in this regard. The Institute has sufficient non-teaching staff (Librarian, admin staff, supporting staff & technical staff). However, the appointments of the teaching staff have not been made as per AICTE/MDU norms and as such the Institute is required to follow AICTE/MDU norms for appointment of faculty and that too in the prescribed cadre ratio.
3. **Building:** The institute has sufficient built up area including Director's office, Admin offices, class rooms, tutorial rooms, conference room and computer lab etc.
4. **Library:** The Committee also visited the library of the institute and found that there were a total of about 1264 books (155 titles) meant for BBA Course. There was an addition of 360 books in the current year. However, the institute is advised to add more standard books yearly as per norms and as per revised curriculum. The Institute has also subscribed to about 34 Journals (33 national and 1 international) and one package of e-journal. Nine daily newspapers and six magazines were also subscribed by the institute. There is sufficient seating arrangement for students in the Library.
5. **Computer Lab:** The institute has computer lab housing in all 120 P-IV computers, 9 printers and adequate power backup. The requisite licensed software such as MS-Office, Turbo C++, Tally, Norton Antivirus etc. for the BBA programme are available. Further, there is 4 MBPS dedicated Internet connection from Reliance.
6. The Institute has all general amenities such as Canteen, Power backup, Transport facility, and Gensets.

Recommendations

In view of the above observations, the committee recommends the extension/continuation of BBA course with an intake of 60 seats, w.e.f. the session 2011-12 at Kedar Nath Aggarwal Institute of Management, Charkhi Dadri, Haryana.
