In pursuance of the decision of the Academic Council taken vide resolution no. 22 dated 15-04-2013 and E.C. Resolution no. 21 dated 26-04-2013 respectively, an Special Inspection/Enquiry was constituted. The above said committee visited the college on dated 29-05-2013 and again on 16.08.2013 The Inspection-cum-Enquiry report has been placed before the Academic Council for consideration. After considering the Enquiry report the Academic Council vide its Resolution No.21 dated 23.08.2013 that in the light of the latest Inspection Report, Admission be allowed in the college and that the college be also required to make up the deficiencies pointed out by the Committee. The matter under reference is yet to be considered by the Executive Council. The recommendation of the Academic Council has been approved by the Vice-Chancellor in anticipation of the approval of E.C. and has allowed to convert the status of the College from No Admission Category to Admission Category provisionally for B.Ed. regular course for the session 2013-14 and also allowed to place the matter before the Executive Council for consideration. Accordingly, status of your college has been converted to No Admission Category to Admission Category provisionally subject to final outcome of the decision of Executive Council.
