Report of the Committee that visited National Power Training Institute (NPTI), Sector-33, Faridabad to verify the available infrastructural facilities for continuation of provisional affiliation for MBA (Power Management)

---

The Inspection Committee comprising Prof. H. Ghosh Roy and Prof. Neelam Jain visited National Power Training Institute (NPTI), Sector-33, Faridabad on 22.7.2012 to verify the available infrastructural facilities for:

Extension/Continuation of provisional affiliation for existing MBA (Power Management) with an intake of 120 seats for the session 2012-2013.

**Observations:**

The inspection committee physically verified the infrastructural facilities viz. building, computer lab, staff, library, class-rooms, furniture etc. for above proposals and makes the following observations:

1. Campus: The Institute has lush green campus scattered over 16 acres in Sector-33 of Faridabad. The Institute has a cluster of buildings including Academic-cum-Admn. Block, Auditorium, Residential Complex, Executives as well as boys Hostels, Open-air Theatre, Gymnasium etc.
2. Library: The Institute has a library having in all 8483 books and 416 titles related to Management and Power Management. The existing books are adequate to meet out the requirements of the present programme. The Institute has subscribed to 50 Journals (12 international and 38 National) related to Management and Power Management. The Institute has subscribed to INDEST-AICTE consortium online-journals plus e-journal, Book Bank facility with additional 1000 books. The Institute has added the books worth Rs. 7 lac during previous year.
3. Class Room: The Institute has 4 classrooms/lecture theatres of seating capacity of 60 each and 8 Syndicate Rooms (4 with seating capacity 60 and 4 with seating capacity 20) which are more than adequate for the existing programmed. Class-rooms have been upgraded with sound system and projector.
4. Faculty: The Institute has 33 faculty (4 Professors, 14 Associate Professors/Reader and 15 lecturers) which are more than adequate as AICTE/MDU norms. (Faculty details and related documents enclosed)
5. Computer lab.: The institute has two computer labs in all 120 computers, 20 printers and adequate power backup, which are more than adequate for the existing programme. The Institute has all necessary softwares. The Institute has Wi-Fi Campus besides broadband Internet Connectivity in all computer labs. (Details enclosed)
6. GIS Resource Centre and CBT Dev. Centre: The Institute has got very good GIS Resource Centre and Computer-Based Training Development Centre.
7. Hostel, Canteen and Transport Facilities: The Institute has got very good hostels for girls and boys or. its premises alongwith canteen and Transport facility.

In view of the above observations, the committee recommends that provisional affiliation for existing MBA course with 120 seats for the session 2012-2013 may be granted National Power Training Institute (NPTI), Sector-33, Faridabad:
