Pursuant to the decision of Academic Council vide resolution no. 23 of its meeting held on 16.08.2012, a show cause notice dated 12.09.2012 was served upon you asking to show cause as to why disciplinary action amounting to withdrawal of affiliation be not initiated against your college for not complying the University directions and fail to make up the deficiencies pointed out in the inspection report with in the stipulated period and also in view of the positions explained in the said show cause notice under reference. Your written reply/representation, if any, in response to this notice was to be reach to the Registrar of this University within 21 days. It was also informed to you that non-reply to this notice would be presume that you accept the decision and have nothing to say in this regard and a final decision as considered just and appropriate under the University Rules would be taken by the competent authority.

In the mean time the NRC of NCTE in its 211th meeting held from February 19th to 21st 2013 has also decided that the order of withdrawal of recognition stands for derecognized courses in respect of I.P.S. School of Management and Education, Jind Road, near Jind Bye Pass, Nehru Colony, Rohtak. In other words the Central Body has also decided to with stands its earlier order of withdrawal of recognition of your college

On the basis of recognition granted by the NCTE, the University granted the conditional provisional affiliation to I.P. College of Education, Ridhal Road, VPO Jassia, Distt. Rohtak for running B.Ed., B.Ed. add., M.Ed., B.P.Ed. and C.P.Ed. courses with certain conditions to be fulfilled by the College.

same was considered by the Vice-Chancellor and ordered to place the whole matter before the Academic Council alongwith letter of Higher Education Commissioner, Haryana and inspection reports of the Colleges for consideration and decision. The Academic Council vide Reso. No. 30 of its meeting held on 11.7.2011 resolved as under:-

RESOLVED THAT THE CATEGORIZATION AS AT (i) ABOVE BE NOTED AND THAT ALL THE COLLEGES PLACED IN CATEGORY 'C' BE REQUIRED TO MAKE THE DEFICIENCIES WITHIN A PERIOD OF 4 MONTHS, SO AS TO REPORT THE NEW STATUS/POSITION TO THE ACADEMIC COUNCIL SOON THEREAFTER.

In compliance with the above decision of the Academic Council of University, all the Colleges of Education including this college were again asked vide letter dated 26.7.2011 to complete the deficiencies and submit report within the above stipulated period of four months, failing which disciplinary action in terms of Act, Statutes and Ordinances of the University already conveyed shall be initiated.

After expiry of the above stipulated period, various inspection committees were appointed to inspect the Colleges and submit the reports on the Quantified Inspection Proforma by categorizing the Colleges as in category 'A','B' and 'C' on the basis of required number of eligible and physically present approved teaching faculty, non-teaching staff, infrastructure facilities and other support systems as per norms of the NCTE/University.

The inspection committee submitted its report and placed the college in category 'C' in respect of B.Ed and M.Ed. (no inspection of the college was carried out for the courses i.e. B.P.Ed. and C.P.Ed.) courses in view of glaring deficiencies with regard to non availability of required number of approved eligible teaching faculty, non-teaching staff, supporting staff, infrastructural facilities and other support systems as per norms of the NCTE/University/State Govt and failed to comply with the above directions of the University.

As per above decision of the Academic Council, the Vice-Chancellor ordered to place the report of the inspection committee of the college alongwith reports of other 'C' category Colleges of Education for consideration and decision. The Academic Council vide Reso. No. 8 of its meeting held on 29.6.2012 resolved as under:-

The University Administration considered the whole matter and took serious note of all and decided to enquire into whole episode including related issues relating to the colleges managed by Sh. Joginder Singh Dalal including this College by constituting an enquiry committee under the convenership of Prof. Rajbir Singh, Deptt. of Psychology, M.D. University, Rohtak alongwith three other members to look into the matter and submit report after making inspection/enquiry of all the these Colleges including college under reference.

The Enquiry Committee visited all the Colleges/Institutions including this College on 19.7.2012 during working hours i.e. between 10.00 A.M and 3.00 P.M. and submitted its report.

The report of the enquiry committee was considered and in view of the observations of the enquiry committee, taking into consideration the fate of the students and all other aspects, the Vice-Chancellor ordered to place these Colleges of Education including this College under 'No Admission Category', in anticipation of approval of the Academic Council/Executive Council of the University, for admissions to all the courses run by the above these institutes/Colleges including the college under reference affiliated with this University for the session 2012-13 till the issues resolved with the following further orders:-

- i) That Detail Marks Cards/Degree of the existing students of above institutes be issued directly by the concerned examination branches of this University and a press note to this effect be also issued for information of the students and same also be uploaded on the University Website.
- That for taking further disciplinary proceedings against all the above Colleges/institutes for all the courses affiliated with this University in view of the enquiry report as well as reports of earlier inspection committees and complaints against the management in the past be placed before the Academic Council.
- iii) That the above action of the University be reported to the NCTE and other concerned.

In terms of the above orders of the Vice-Chancellor all the colleges including the college under reference, were placed under 'No Admission Category' vide this office Notification No. CB-IX/2012/10036-57 dated 26.7.2012 and intimation in this regard was also sent to the Central Body i.e. NCTE.

College of Education, Jassia, Distt. Rohtak with this notice asking them to show cause as to why disciplinary action amounting to withdrawal of affiliation be not initiated against the college for not complying with the University directions and failed to make up the deficiencies pointed out in the inspection report within the above stipulated period and also in view of the position explained above. The written reply/representation, if any, in response to this notice was to be reach the Registrar within 21 days from the date of dispatch of this notice. It was also intimated them that non reply to the notice would be presumed that they accepted it and have nothing to say in this regard and a final decision as considered just and appropriate under rules shall be taken by the competent authority. A copy of this Show Cause Notice was also sent to the Central Body i.e. NCTE alongwith a copy of inspection/Enquiry report for information and further necessary action at their level as it may deem fit.

In response to the above said Show Cause notice, one Sh. Ashok Kumar on behalf of President of the said college submitted the reply to the show cause notice vide letter dated 27.09.2012 which is also without any supporting documents with regard to completion of deficiencies / shortcomings pointed out by the inspection committee as well as conditions laid down by the University. However no reply on behalf of Principal has so far been received. Further the society of the college has also not intimated any kind of change in the college management as asked for in terms of above decision of Academic Council.

In the meantime the office was in receipt of a copy of minutes of the NRC of NCTE in its 207th meeting held from November 27th to 13th 2012 in which the NRC of NCTE also decided that the order of withdrawal of recognition stands for derecognized courses in respect of I.P. College of Education, Rital Road, VPO Jassia, Distt. Rohtak. In other word the Central Body also decided to with stands its earlier order of withdrawal of recognition of the college for all the existing courses on the basis of observation made in the proceeding of the minutes of NRC of NCTE. Now the formal letter dated 24.01.2013 of withstanding of earlier order of recognition of all the courses in respect of this college has also been received from the NCTE.

The matter in its totality and in view of withdrawal of recognition by the Central Council i.e NCTE was placed before the Vice-Chancellor, who, in anticipation of the approval of the Academic Council/Executive Council ordered
