- 5. Extension in B.Sc. Hons. (Mathematics) 3rd year course and its continuation in 1st and 2nd year with 40 seats w.e.f. session 2016-17.
- 6. Extension for 160 additional seats i.e. (240 to 400) in B.Sc. (Non Medical) 2nd year course and its continuation in 1st year w.e.f. session 2016-17.

After fulfillment of the deficiencies given in the Inspection report, compliance report be sent to this office within three months.

Further, the Vice-Chancellor has not allowed Provisional Affiliation for introduction of M.Sc.(Zoology) course and additional seats in M.Sc.(Chemistry, Physics and Mathematics) w.e.f. the session 2016-17.
