1. B.A. 1st year Course - 240 seats w.e.f. the session 2016-17
2. B.Com. 1st year Course - 240 seats w.e.f. the session 2016-17
3. Extension in B.Sc. Hons. (Physics) 3rd year course with 60 seats and its continuation in 1st and 2nd year under S.F.S. w.e.f. the session 2016-17.
4. Extension for additional 60 seats i.e. (60-120) in B.Com. Hons. 3rd year course and its continuation in 1st and 2nd year under S.F.S. for the session 2016-17.
5. Extension in B.Voc. (Retail Management) 2nd year course and its continuation in 1st year with 50 seats under S.F.S for the session 2016-17.
6. Extension in B.Voc. (Software Development) 3rd year course and its continuation in 1st and 2nd year with 50 seats under S.F.S for the session 2016-17.
7. Additional 20 seats i.e. (40 to 60) in M.Sc. Physics under SFS w.e.f. the session 2016-17.
8. Additional 80 seats i.e. (80 to 160) in B.Sc. (Non-Medical) under SFS w.e.f. the session 2016-17.
9. Additional 60 seats i.e. (120 to 180) in B.Com (Hon.) under SFS w.e.f. the session 2016-17.

Further you are hereby asked to initiate the process for appointment of regular teachers through duly constituted Selection Committee of the University immediately as per qualifications prescribed by the U.G.C./ State Govt.

After fulfillment of the deficiencies given in the Inspection report, compliance report may kindly be sent to this office at the earliest so that further action may be taken accordingly.
