26. Disaffiliation of SGT Institute of Engineering & Technology, Budhera, Distt. Gurgaon

Considered

i) the disaffiliation of SGT Institute of Engineering & Technology, Budhera, Distt. Gurgaon in view of the NOC issued by the Haryana Government vide letter No. 100-101/Colleges dated 27.1.2016 (Annexure A/31 page 145, already circulated), approval of the AICTE vide letter No. North-West/1-281419/201/2016/Progressive Closure dated 10.4.2016 (Annexure A/32 page 146, already circulated) and the request made by the Director, SGT Institute of Engineering & Technology, Budhera, Distt. Gurgaon vide letter No. 4/AICTE/SGT/15-16/5000 dated 04.5.2016 (Annexure A/33 page 147, already circulated). The courses of B-Tech/M Tech. being run by this college shall be discontinued in stages/progressive manner as per sub clause (i), clause-12 of Statute 38 re-produced below:

"The discontinuation in respect of an integrated course of study/subject for which it is affiliated shall be in stages as under:

- i) In the first year, admission to Part-I class will be discontinued and admission for Part-II, III will continue
- ii) In the 2nd year, admission to Part-II class will be discontinued and admission for Part-III, if any, will continue.
- iii) In the 3rd year, there may be no admission."

And

ii) The following recommendations of the Academic Council made vide Reso. No. 31 of its meeting held on 30.08.2016:

RESOLVED THAT DISAFFILIATION OF ABOVE COLLEGE BE RECOMMENDED TO THE EXECUTIVE COUNCIL FOR APPROVAL AND THAT THE DISAFFILIATION SHALL BE IN PHASES AS PER STATUTE 38.


