Dear Sir / Madam,

The Indian Council of Social Science Research has a Study Grant Scheme for scholars who are doing Ph.D in the filed of Social Sciences. The purpose of study grant is to provide financial assistance to **Ph.D** scholars in the field of social sciences for consulting Libraries/Archives/Data Centres in different cities/town in India for collecting research material. The Scheme is administered by six Regional Centre of the Council located at Delhi, Mumbai, Kolkatta, Chandigarh, Hyderabad and Shillong. A Ph.D scholar who wants to avail this facility has to apply to the Director of the Regional Centre within whose jurisdiction he is registered for a Ph.D

The North-Western Regional Centre of the ICSSR provides study grant to those scholars who are registered for Ph.D in the Region i.e. Punjab, Haryana, Himachal Pradesh, Jammu & Kashmir and the U.T. of Chandigarh.

Eligibility:

- A scholar should be registered for Ph.D in social sciences in one of the recognized Universities in North-Western Region i.e. Punjab, Haryana, Himachal Pradesh, Jammu & Kashmir and the U.T. of Chandigarh.
- A scholar who is not receiving any financial assistance from ICSSR, UGC or any other agency, is entitled to get financial assistance under this scheme;
- Social Scientists who want to revise their doctoral thesis for which a degree has already been awarded are not eligible to get financial assistance under this scheme

Entitlement:

An allowance of Rs.400/- per day to meet boarding and lodging expenses for a maximum period of 30 days in a financial year;

An additional amount of Rs.1000/- to meet conveyance and

miscellaneous expenses;

 Second class sleeper railway/bus fare from the place of residence/University where scholar is registered for Ph.D to the place of visit (where libraries are located) and back. A scholar is allowed to visit two cities by round trip via shortest route.

Applications for the financial assistance under this scheme are to be sent in the prescribed form along with the recommendation of the Head of the University Department/Research Institution. The application form is enclosed.* The application for a grant under this scheme can be sent throughout the year. The research scholars are required to send their applications sufficiently in advance of their proposed visit keeping the calendar in mind.

I shall be thankful if you could kindly arrange to display this information on the Notice Board and also bring to the notice of individual faculty members / all the research scholars who are doing Ph.D in your Department/College in the field of social sciences.

Scholars interested in availing themselves of study grant facilities for consulting the Libraries may send in their application to the undersigned duly filled in and completed with necessary formalities. Incomplete applications will not be considered.
