The candidates who could not deposit their fee in the earlier counseling(s) and were higher in merit be given preference for admission. Seats, still remain vacant, if any, be filled upto 20.8.2016 without any late fee. The admission notice be displayed by the Head of the Departments on the Notice Board as well as on the University Website. .

The reservation policy and other provisions as mentioned in the Prospectus be followed. With regard to conversion of seats, the action may be taken in view of letter No.AC-1/F-330/2016/13946-87 dated 13.07.2016 which provides as under:-

- 1. "That the seats reserved for different categories will be first offered to the candidates of the concerned reserved category and if any seat of reserved category remains vacant, the same may be converted into General Category by the concerned HOD and the same will be filled up strictly on the basis of merit. However, if any candidate of reserved category comes for admission during counseling, he/she will be considered first for admission."
- 2. At the end if the candidates of Haryana General are also not available then the seats may be filled up on All India Basis.

Further necessary action may be taken accordingly.
