Kindly refer to this office letter No.ACS-IIIF-3/2016/20397-20425 dated 9.9.2016 on the subject cited above In this connection, I am directed to inform you that the meeting of the Faculty of Humanities vide Reso. No.3 & 4 of its meeting held on 31.08.2016 resolved as under:-

3. Considered the recommendations of the U.G. Board of Studies in English and Foreign Languages made vide Reso. No. (a) of its meeting held on 18.07.2016 as under:-

The syllabus, scheme of examination, workload, and instructions to the paper setter and students of B.A. Part III(English Compulsory), Semester V w.e.f. 2016-17. The Schemes, and instructions to the paper setter and students for semester VI for the session 2016-17 will be taken up in the UG BOS meeting to be held in December 2016. Text prescribed will be the one which CDLU, Sirsa will get published as per Annexure-II Pages 8-10(already circulated).

RESOLVED that the syllabus of B.A.(English)5th Semester be approved and the Scheme of Examination be recommended to the Academic Council for approval.


Further Resolved that the Dean, Faculty of Humanities be authorized to forward the recommendations of the UG BOS in English (to be made in the month of December) for the Syllabus and Scheme of Examination of BA-III(English)6th Semester for the Session 2016-17.

4. Considered the recommendations of the P.G. Board of Studies in English and Foreign Languages made vide Reso. No. 2 of its meeting held on 18.07.2016 that the minor changes in the syllabus and Scheme of examinations of MA (English) 1st to 4th / 7th to 10th semesters from the session 2016-17 under CBCS may be prescribed as per Annexure-III pages 11-15.(already circulated)

RESOLVED that the Syllabus of M.A. English 1st to IVth Semester be approved and the Scheme of Examination of the Course be recommended to the Academic Council for approval.

FURTHER RESOLVED that in view of the decision, the Executive Council taken vide Resolution No.22 in its meeting held on 3.8.2015, the Choice Based Credit System is not to be introduced in 5-Year Integrated (Hons.) Course. However, the Faculty approved the contents of the syllabus of 5-Year MA (Hons.) English Integrated Course 7th to 10th Semester from the session 2016-17. The Scheme of examination be supplied by the Head, Department of English accordingly after consulting the Controller of Exams. with regard to code of the papers. The Scheme of Examinations of the course be referred to the Academic Council for approval.

In view of the above, you are requested kindly to supply the Hard Copies alongwith CD or through E-mail Syllabus and Scheme of Examinations of the above courses to this office urgently so that the same may be got uploaded on the university website. The syllabi of P.G.Courses may be supplied as vetted by the Director, I.Q.A.C.
