Application on plain paper alongwith processing fee in the form of Demand Draft of Rs. 1,000/- (Non-Refundable) are invited from the eligible candidates for migration to MBA, MCA, B.Pharmacy 2<sup>nd</sup> Year and Law courses in University Teaching Departments. Selected candidates shall have to pay Rs. 25,000/- and fee for Inter-University Migration Rs. 30,000/- after the migration is allowed.

The applications must reach on or before 22/12/2016 by 5:00 P.M. in the R&S Branch, M.D.U, Rohtak and the interview of the candidates will be held on 27/12/2016 at 3 P.M. in the Office of Dean Academic Affairs, M.D.University, Rohtak.

The candidates are required to fulfill the following conditions:-

- 1. The candidate who has compartment in any subject will not be eligible for migration. However, this condition shall not be applicable to the students who are from affiliated colleges of M.D.University, Rohtak.
- 2. The migration to 1<sup>st</sup> year of the course is not permissible in MBA, MCA and B.Pharmacy Courses. Migration will be allowed against the seats falling vacant within the total intake sanctioned for the particular class in Third Semester (2<sup>nd</sup> year).
- 3. The duration of the course must be the same as in MDU.
- 4. As per requirement, the candidate seeking migration must have qualified in the entrance test and passed qualifying exam, recognized by MDU with the minimum marks and subject as prescribed for admission to the course by MDU,Rohtak. The candidate will have to produce NOC from the college and also remarks/certificate regarding his/her conduct and behavior during his/her stay in the Institution
- 5. The candidate will have to deposit Rs. 1000/- as application processing fee and Rs. 25000/- as migration fee and Rs. 30000/- for Inter University Migration after the migration is allowed.
- 6. Migration will be allowed against the seats falling vacant within the total intake sanctioned for the particular class at the time of admission to the first year of the course and onwards in law courses.
- 7. All the candidates who apply for migration must have a valid reason such as compassionate ground-transfer of parents, medical grounds, security reasons and likewise.
- 8. The candidates migrating from other Universities must have secured atleast 50% aggregate marks in the 1<sup>st</sup> year of the course of the University/Institute and should have passed in all the papers (Both theory and practical) in the 1<sup>st</sup> attempt.
