  - (g) Sampling details and procedure
  - (h) Inclusion and exclusion criteria
  - (i) Study procedure details
  - (j) Written MOU/Consent for providing samples
  - (k) Certificate of Biosafety (if applicable)
- 3. Every page should be numbered and signed by Principal investigator.
