
This is, with reference to your letter No.3/18-2015 Sch. (2) dated 29.07.2015 on the subject cited above.

It is to inform you that the Executive Council vide Resolution No. 22 in its meeting held on 12.8.2014 has approved the fee structure for Non-Govt. aided Colleges and self financing degree colleges affiliated with this University to be applicable w.e.f. the session 2015-16. However, later the matter of rationalizing of fee in Universities and Colleges in Haryana was referred to the State Government and a Committee under the Chairmanship of the Vice-Chancellor, Ch.Bansi Lal University, Bhiwani was constituted. The Committee has already submitted its recommendations to the State Government.

The matter has been considered by the Vice-Chancellor, who has ordered that the fee structure already approved by the Executive Council vide resolution referred to above may be applicable in respect of Self Financing Scheme Colleges/Courses affiliated with this University for the session 2015-16 only to avoid problem to the students in claiming scholarships. A copy of the fee structure is enclosed. There is, however, no change in fee in respect of Non-Govt. aided Colleges.
