### **Revised Terms and Conditions**

- 1. The Maruti ECO of good condition fitted with Stretcher, Back long seat, First Aid Box, Ambulance saran and Blue light and One Oxygen Cylinder of 10 Lts. capacity is required from 7.00 p.m. to 7.00 a.m. on next day for whole the month. Refilling charges of the cylinder will be borne by the owner/firm/NGO.
- 2. The ambulance must have valid complete documents viz R.C (Registered as Ambulance) insurance, permit, Pollution Certificates etc. but the Model of the vehicle should not be prior June, 2015.
- 3. The successful firm/owner of the vehicle will have to deposit a security amounting to Rs.10,000/- (Ten Thousand only) which will be refundable without any interest on satisfactory completion of the period of contract.
- 4. The vehicle will be used although within 10 kms radius tentatively and for 800 kms the rates already fixed by the University for University Scorpio or revised from time to time. The successful firm/owner has to make available the Ambulance with in one month from the date of receipt of supply order otherwise contract will be treated as cancelled and given to the next owner/firm.
- The University will have the right to use the Ambulance for outside journey also and If it is used for outstation journeys, the payment will be paid as per University Scorpio rates prevailing from time to time.
- 6. All expenses viz. as Salary of Driver, Insurance, taxes, Permit, POL charges, wear and tear charges, Challan etc. will be borne by the Owner /firm of the vehicle.
- 7. The driver of the ambulance should must have valid driving license and be of soft spoken language.
- 8. The Ambulance must be ready in all respects during the specified period, if it goes out of order, the owner/bidder will have to provide an alternate Ambulance within an hour.
- 9. When-ever the owner/firm fails to provide the Ambulance/alternate Ambulance in time, a penalty of Rs. 1000/- (Rs. One Thousand only) per time during in a month will be levied and the amount will be deducted from the monthly payment.

- In case, the owner backs out of contract, their security money will be forfeited 10. besides any other action, as is deemed fit by the University.
- The payment will be made after every 2 (two) months by the Programme 11. Coordinator, Youth Red Cross, M.D. University, Rohtak only on the basis of satisfactory services.
- Initially, the contract will be for three years, but may be renewed further year to year 12. basis only on satisfactory services on the same charges and not beyond 02 more years with new vehicle.
- Either of the party shall have the right to terminate contract by giving three months 13. notice in advance.
- Other condition, if any, will be laid down with mutual consent at the time of 14. conclusion of contract.
- In case of any dispute, the decision of the Vice-Chancellor, M.D. University, Rohtak 15. will be final.
- The Driver/service provider has to maintain a log book of the ambulance and will 16. remain under the supervision of the Transport Officer, M.D. University, Rohtak.
- The inspection will be carried out by the Medical Officer, M.D. University, Rohtak 17. from time to time and payment of vehicle charges will only be made on the report of the Medical Officer.
- Legal jurisdiction of dispute, if any, will be Rohtak. 18.
