28. Amendment to Clause 11.2 of the Ordinance for Bachelor of Architecture 4869-4872 on 18.08.17

Considered the recommendations (Annexure A/27 pages 215-216, already circulated) of the Committee constituted by the Vice-Chancellor regarding promotion rules of the students of B.Arch. course to be applicable w.e.f. 2017-18. Accordingly, the clause 11.2 of the Ordinance for Bachelor of Architecture is proposed as under:-

(b) A candidate who has paid dues for the Higher Semester/Class but subsequently becomes ineligible for promotion shall not be required to pay the dues again on the admission after meeting the above conditions.
