I have been directed to refer the decision of the Director & Spl. Secretary Higher Education, Haryana, Shiksha Sadan, Sector-5, Panchkula conveyed vide its letter D.O. No. 9/21-2016-CII(2) dated 30.12.2016 regarding reviewing the policy of Provisional N.O.C to S.F.S Degree College in the State of Haryana (copy enclosed).

Higher Education Haryana, Panchkula regarding obtaining permanent N.O.C. at the earliest possible, otherwise admissions in your college would not be allowed w.e.f. the coming session i.e. 2017-18 and no further affiliation for introduction/additional seats in any U.G./P.G. course/subject shall be granted.

We have issued NOC's to the Degree Colleges working on Self-finance basis in the State of Haryana from time to time working with the various Universities in the State but the NOC's were issued for a limited period but they have not applied for the regular/permanent NOC and this I have too noticed that Universities are giving affiliation to these Institutions from time to time.

I would like to request the Vice Chancellor's that they should not allow affiliation to such Institutions having no permanent NOC issued by the Department of Higher Education and issue directions in this regard to all the Institutions affiliated to their Universities, If they will not do so I am going to start the process of withdrawing the provisional NOC's. I am also directing the Principals and Managements of such Institutions to first of all take the permanent NOC from the Department after completing the all required documents and formalities. I am also issuing a Public notice in the interest of the students to not to seek the admission in such Institutions and if they still, it will be purely at their own risk.
