It is hereby notified that consequent upon the extension of last date for admission/counselling for M.Ed./M.Ed (Special) Course upto 01.10.2018 with late fees of Rs. 1,000/-, the schedule for receipt of online Registration Return-cum-Examination form of M.Ed/M.Ed-Special Course in respect of admissions with late fees have been extended and fixed as under:-

1.	Online submission of Registration Return-cum-Examination forms and generating Challan for depositing fees without late fees in respect of M.Ed. Course (Regular Course)	Upto 11.10.2018
2.	Submission of Hard Copy of the Registration Return alongwith required Certificates/Documents for checking of Eligibility and Migration Certificates, if any with the proof of depositing fees (Challan of fees) in the concerned bank without any late fees	Upto 17.10.2018 (being holiday on 15.10.2018)

The students whose admissions were made within normal date of admissions and Registration Return has not been generated by the College/Institute till date, the RR-cum-exam form will be accepted alongwith RR late fees as per rules. The Challan of such students needs to be generated from the Fee Section, Account Branch of the University manually M.D. University, Rohtak.

Further, One time fee Challan (Sports fee, Youth Fee and Techno Management fee) should also be submitted (Hard Copy) in the Registration and Scholarship branch at the time of submission of Registration Return before the last date as per schedule, without which the RR will not be accepted. The Instructions/Guidelines circulated vide letter No. R&S/R-7/18/6715 dated 13.09.2018 should also be strictly adhered while sending the Registration Return.
