
"All examinations of foreign Universities/Boards/Examining Bodies which are recognized by Association of Indian Universities have been recognized by this University."


Resolved that if no specific clarification is received from the AIU regarding equivalence of Degree, the following sub-committee may consider the case and make its recommendations in the matter:-


