



The Committee considered the matter with regard to not holding the counselling by IMSAR for five additional seats for Ph.D. Programme on 10.12.2018 due to non receipt of hard copy of the minutes whereas the minutes of the GRC dated 04.12.2018 were sent to all concerned through email by the Academic Branch on 07.12.2018.

After considering the matter in detail the GRC resolved that the counselling for the said seats be held on 17.12.2018. During the meeting, the Director, IMSAR also requested for increase of 08 more additional seats for Ph.D. Programme.

The committee considered the request of the Director, IMSAR and resolved that the matter be got recommended from the Departmental Committee of the Institute and the recommendations of the Departmental Committee be treated as approved by the GRC. Accordingly the Director, IMSAR has sent the recommendations of Departmental Committee dated 12.12.2018 for 08 additional seats for Ph.D. Programme.

In view of the above the GRC resolved that the counselling for all the 13 additional seats (05+08) be held on 17.12.2018 with the following conditions:-

1. The total number of seats under a supervisor should remain within the limit as per clause – 11 of the Ph.D. Ordinance.
2. The reservation be given on the total seats (including increased seats) as per reservation policy mentioned in the Prospectus.
3. The total seat in respect of IMSAR for Ph.D. Programme 2018 be read as under:
