Following item has been considered in the meeting:-

1. Prescription of Development fee for the course P. G. Diploma in Translation in English/Hindi being run in the Department of Hindi

Considered the recommendations of the Departmental Committee of Hindi that the Development Fee of P. G. Diploma in Translation in English/Hindi course being run in the Department of Hindi be prescribed as Rs. 1500/-p.a., per student w. e. f. the session 2018-19.

Resolved that the above Development Fee for P. G. Diploma in Translation in English/Hindi be prescribed in addition to the fee already prescribed for the course.

2. Increase of fee for the courses being run in Institute of Hotel and Tourism Management (SFS)

Considered the recommendations of the Departmental Committee submitted by the Director, IHTM, M. D. University, Rohtak that the Tuition Fee and Development Fee of MHM&CT(5-Five Years and 2 Years), MTTM, BHM&CT and BTTM Programmes being run in the Institute of Hotel & Tourism Management, M. D. Resolved that the above recommendations of the Departmental committee be referred to the Executive Council for approval w. e. f. the academic session 2018-19 as under:-






